Head Start Policy Council

The TCA Board of Directors has established and maintained a formal structure of shared governance through which parents, particularly the Head Start Policy Council, can participate in policy making or in other decisions about the program.

The Head Start Policy Council and the Board of Directors share responsibility for overseeing the delivery of high quality services to children and families in accordance with Head Start legislation, regulations, and policies. Through the Policy Council and through Parent Committees at each Head Start site, parents and other community representatives are empowered to actively participate in the shared decision-making process.

Policy groups – the Policy Council at the grantee agency level and the Policy Committee at the delegate agency level – have policy-making authority, and therefore, are governed by locally determined bylaws that ensure clarity and consistency in function and purpose.

Parent Committees provide every parent of an enrolled child with the opportunity to assist in the development of activities that address their interests and needs and that support the education and healthy development of their children.



TCA PROGRAMS AND SERVICES

HEAD START

Launched in 1965 as a comprehensive child development program, Head Start is currently a primary support structure to low income children and their families nationwide, providing early childhood education, social services, parent involvement and services for children with disabilities. The overall purpose of Head Start is to promote the school readiness of low-income children by enhancing their cognitive, social and emotional development and to assist parents in developing and implementing a path out of poverty moving the family towards self-sufficiency.

EARLY HEAD START

Early Head Start provides family-centered services for low-income families with very young children. It is designed to promote the development of the children and to enable their parents to fulfill their roles as parents and to move towards self-sufficiency.

COMMODITY DISTRIBUTION PROGRAM

Commodity Distribution Program which supplements the food needs of low and moderate-income households in Orleans Parish. This program assists people by promoting smarter shopping, wiser menu preparations, and greater nutritional awareness.

WORKFORCE DEVELOPMENT CENTER

TCA's Employment Development Center is linked with area schools, employers and organization to provide services, which are designed to make job development attempts more successful.

WATER ASSISTANCE

The Water Service Assistance Program provides assistance with Sewerage & Water Board bills to elderly and disabled persons who are unable to pay the bill due to emergency circumstances.

ENERGY ASSISTANCE

The goal of Low-Income Home Energy Assistance Program (LIHEAP) is to assist eligible households in meeting the cost of home energy for heating and cooling. The second goal is to conserve energy and reduce energy costs and low-income households through weatherization of dwelling units.

TRANSPORTATION PROGRAM

The TCA's Transportation Program provides transportation services for the elderly and/or handicapped in areas where there is a gap in special transportation services. The program gives people access to shopping, medical appointments, education, training and recreation in the community.

YOUTH WORK EXPERIENCE

The TCA Youth Work Experience Program provides job placement services to low-income and disadvantaged full-time students between the ages 16 and 21. The program operates in two cycles, Fall and Summer

HOMELESS ASSISTANCE

In partnership with Unity for the Homeless, TCA provides assistance to customers for 1st month rent and deposit, utility payment and furniture. Interventions may be provided customers who may require assistance to overcome barriers, such as poor tenant history, credit history and discrimination based on ethnicity, gender, family make-up and income source.

INDIVIDUAL DEVELOPMENT ACCOUNTS

The Total Community Action Individual Development Account (TCA-IDA) program is administered by the TCA in partnership with the Total Community Action Federal Credit Union (TCAFCU). The program is designed to encourage savings and improve personal financial planning to help low-income individuals build productive assets and self-sufficiency.

TAX ASSISTANCE CENTER

Total Community Action Tax Assistance & Education Center is organized to educate the community about benefit of the EITC, particular low-income workers and businesses. Also the Center provides free income tax filing through the Internal Revenue Services – Volunteer Income Tax Assistance program. TCA operates 9 free tax preparation sites citywide.

FINANCIAL FUTURES

TCA Financial Futures is part of an eight-point poverty reduction strategy that designed to encourage savings and improve personal financial planning to help low-income individuals build productive assets and self-sufficiency. Specifically the program assists customers with exploring the wealth of services available to help them move to more permanent self-sufficiency and acquire assets many previously believe as unattainable.

HEAD START

Head Start Early Childhood Services: Total Community Action continued to fulfill its mission of promoting the school readiness of low-income children through the provision of family-centered services that promote the healthy development of the children and families through comprehensive health, developmental and family services.

TCA provided these services through multiple program options including center-based classrooms and family child care appropriate to the needs of our population. TCA's early childhood programs include Head Start, Early Head Start, delegate Head Start and Early Head Start, and Child Care partners.

The most significant event in 2009-2010 was the expansion of the program through a highly competitive American Recovery and Reinvestment Act grants resulting in an expansion of 78 Early Head Start children. The ARRA expansion resulted in an additional \$2.1 million dollars in funding over a two year period.

This expansion resulted in the total additional enrollment of 281 children in thirteen counties. Also unprecedented was the startup of the expansion programs within four months of the grant awards. This startup included furnishing and equipping

classrooms and socialization sites as well as the hiring and training of new staff.

Total Community Action also received additional one-time ARRA funding which were used to provide COLA increases for staff, quality increases for staff with college degrees, extensive professional development activities and funds for additional playground upgrades, minor renovations, classroom supplies, equipment.

ENROLLMENT, ELIGIBILITY, AND SERVICES

The table at right represents summary data from the Performance Information Report (PIR) that Head Start must submit to the federal government.

FAMILY ENGAGEMENT

Participation of families in the Head Start program is an integral element of Head Start's success. The TCA Head Start program engages parents and families to promote children's healthy development and learning. Families act as advocates for their children and the Head Start/Early Head Start programs by actively taking part in decision making opportunities.

TCA provides consistent, two-way communication that is facilitated through multiple forms and is responsive to the linguistic preference of the family. Families collaborate and exchange information allowing them to share their unique knowledge and skills through volunteering and actively engaging in events and activities at the centers. Teachers seek out information about children, their families, and the communities and integrate this information into their curriculum and instructional practices. Lastly, our programs and families place an emphasis on creating and sustaining learning activities at home and in the

community that extend the teachings of the program so as to enhance each child's early learning and school readiness.

CHILDREN AND FAMILIES SERVED

Total Community Action Head Start Program provided services to a total of 1,752 children and families including delegate agencies. This included 1488 children in the Head Start program serving children ages three to five, and 264 children enrolled in the Early Head Start program serving children ages zero to three.

MEDICAL AND DENTAL SERVICES

Of the children enrolled during the 2008-2009 school year, 98% of the children received a medical examination and 95% received a dental examination. The percentage of children receiving the medical and dental screenings increased from last year's number of 80% and 91% respectively. 100% of the children needing medical or dental treatment were treated.

SCHOOL READINESS

One of the principal goals of the Head Start pAccording to the Office of Head Start and the Louisiana Department of Education, "school readiness" can be defined as: children acquiring the skills, understanding and attitudes; across early childhood developmental domains, to be successful in school and other learning endeavors they may partake in life." Here at Total Community Action, Inc. Head Start our children are not only ready, but our parents and schools/ communities are also ready to support and nurture the learning of their children. School readiness for Total Community Action, Inc. Head Start means that our children are able to assess and track their own literacy and mathematical progress, through face recognition and interactive technology. Our children are acquiring the

"approach skills" needed to establish positive peer and adult relationships, so that they are able to communicate effectively and self-assuredly. They are examining the world through use of the "scientific method" and are able to hypothesize which objects may "sink or float" and whether or not their toys are "simple machines" or "living or non-living." A TCA Head Start child can expressively or receptively communicate as they are able to write and tell a story, by properly formulating their letters and phonetically sounding out their words. Our Head Start children are also health conscious, as they are able to set a table, choose healthy foods and eliminate germs through the washing of their hands and the brushing of their teeth. We at TCA can honestly say our children are "school ready."
