Super Tax Scratch Cash! 2017 OFFICIAL RULES

Super Tax Scratch Cash! 2017 (the "Promotion") begins at 12:01 a.m. CST on February 4, 2017 (the "Promotion Start Date") and ends when all available scratch-off tickets are distributed or at 11:59 p.m. CST on April 23, 2017 (the "Redemption Deadline"), whichever occurs earlier (the "Promotion End Date"), (such period referred to herein as the "Promotion Period"). The Promotion is sponsored by Entergy Services, Inc. (the "Promotion Sponsor"). Volunteer Income Tax Assistance sites and other free tax preparation sites (each individually, a "Participating Tax Preparation Site") will be participating in this Promotion:

1. How to Enter: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. As an eligible participant, you will earn a chance to win a prize by agreeing to save a portion of your 2017 tax refund by completing and submitting IRS Tax Form 8888. Participants will receive one (1) scratch-off ticket for by agreeing to save a portion of your 2017 tax refund by completing and submitting IRS Tax Form 8888.

Participation in the Promotion is voluntary and does not require you to purchase anything from the Promotion Sponsor or the Participating Tax Preparation Sites. To receive a scratch-off ticket without completing and submitting IRS Tax Form 8888, request one in person at the United Way of Southeast Louisiana Office at 2515 Canal Street, New Orleans, Louisiana 70119 or at the Capital Area United Way at 700 Laurel Street, Baton Rouge, Louisiana 70802 (the "<u>United Way Sites</u>"). All requests for tickets must be received while supplies last and by the Promotion End Date. One entry per person. Mechanically reproduced entries will not be accepted. All entries become the property of the Promotion Sponsor and will not be returned.

2. Prizes: There will be a total of 400 scratch-off tickets available through the Participating Tax Preparation Sites or mail-in entry, and all of these tickets will be winners. Each prize is \$5, \$20 or \$50. The odds of winning \$5 are 3:4. The odds of winning \$20 are 1:5. The odds of winning \$50 are 1:20. Total approximate value of all prizes: \$4,100; 300 X \$5 = \$1,500, 80 X \$20 = \$1,600 and 20 X \$50 = \$1,000 (actual value may vary).
